In addition to this, our inspection and audit process is as follows:

- 1. Site safety & audit run via software PROCORE
- 2. Weekly site checklist completed via PROCORE
- 3. Pre-start SWMS review via PROCORE
- 4. Task Observation via PROCORE
- 5. Site safety, quality and environmental checklist via PROCORE

Incident Reporting Systems

All incidents and near misses are reported and investigated via our Project management & document control system PROCORE. Depending on the severity of the incident or safety concern, the matter will be investigated.

Non-conformances around safety are reviewed at the fortnightly team meetings. Appropriate corrective action shall be implemented, to prevent any recurrences of the non-conformance.

Corrective actions shall be taken in proportion to the magnitude of the problem, or at the Senior Leadership Team's direction.

Changes to existing documented procedures resulting from corrective and / or preventive action, shall be recorded and communicated to the appropriate personnel as per Document Control and Record Management Procedure.
